The Skin & Cancer Foundation is a not-for-profit, non government funded organisation which provides specialist treatment for a wide variety of skin diseases.

Since its formation in 1987, The Skin and Cancer Foundation has been at the forefront of developing new and better ways to diagnose and manage diseases of the skin. Founded by a group of 38 leading dermatologists, the Foundation has depended heavily on the voluntary input of this professional group, a number of whom continue to attend and consult at the various Foundation clinics for up to a day each week without charging for their services.

As one of Australia's leading centres for skin disease research and treatment, we conduct regular trials, collect clinical data, perform research into occupational dermatology and support projects in other dermatology centres. Our education arm reaches diverse groups of people including trainee dermatologists and general practitioners and we contribute to continuing professional development for dermatologists through organizing regular Clinical Updates, as well as providing a central location for the majority of Clinical Meetings of the Victorian Faculty of the Australasian College of Dermatologists.


New Appointments

Pathology

The joint venture with Melbourne Pathology -Melbourne Skin Pathology continues to play an important role in the financial sustainability of the Foundation. This year we also acknowledge the leadership and service provided by Dr Graham Mason. This stewardship has ensured that a strong team remain to maintain his legacy. Dr Mason retired on 30 June and we are pleased to welcome Dr Rod O'Keefe, another acknowledged dermopathologist, who has joined MSP.

Victorian Country Women's Association

The Foundation was grateful to be chosen as a 2010/11 principle charity recipient for fund raising from the VCWA. Over \$24,000 was raised by the VCWA. During the year we were pleased to provide information on skin health to VCWA members. Our institution will continue working with the VCWA in this regard. CLINICAL

2010/2011 saw minimal growth in the number of clinical services, primarily in the areas of PDT and to some extent in Skin Cancer Assessment Clinic.

We therefore surveyed members to ensure that our clinics remain relevant and appropriate for training and specialist services as discussed earlier.

Young Dermatologists Join the Foundation

Dr Hugh Roberts and Dr Michelle Rodrigues have joined the Skin Cancer Assessment Clinic. Dr Kamaldeep Sandhu has commenced in the PDT Clinic and Hyperhydrosis Clinic. Dr Shoba Joseph now attends the Phototherapy and Biologics Clinics.

We have also established a skin check program for businesses led by Associate Professor Rosemary Nixon, commencing with Mallesons and Wrigley Mars. This has also highlighted the importance of skin health in the workplace.

Aesthetics Clinic

With support from Solta and Candela the Foundation has acquired a number of lasers to commence training and service provision in aesthetics. To this has been added injectable services.

It is very important that registrars be properly trained and for dermatologists to take a leadership role in the provision of professionally provided aesthetic services. Associate Professor Goodman, Dr Rich and Dr Bekhor, and recently Dr Welsh, have been major contributors to training in these clinics. Our thanks for their assistance.

EDUCATION

Registrars

We are delighted at the continued success of registrars in their Fellowship Examinations. Our congratulations to the Victorian registrars who were all successful in passing their ACD fellowship exams. There is a strong educational program provided at the Foundation and in association with the Victorian Faculty.

The Foundation has been continuing its active education program centred around the Foundation including:

- 1. Skin schools.
- 2. Dermatopathology sessions.
- 3. Clinical meetings.
- 4. Update meetings.

Our thanks go to our members and sponsors for their support of these essential professional development activities.

Congratulations also to Associate Professor Nixon in her appointment as the new Victorian Faculty Chair. We would also like to

congratulate Dr Peter Cowen as the outgoing chair, for his excellent support. The effective relationship between the Victorian Faculty and the Skin & Cancer Foundation Inc. helps to ensure quality education for registrars and consultants. The Foundation is most appreciative of the Faculty's donation of funds to purchase a new camera to be attached to the dermatopathology microscope bank. We have only eight positions on the bank & the camera will enable the images to also be projected up onto a screen and thus allow additional trainees to view and participate in dermatopathology sessions.

We have launched, with the support of four pharmaceutical companies, a Biologics Master Class Program. It has been a pleasure to work with Barbara Radulski, A/Professor Chris Baker, Dr Anna Braue and other team members to develop and implement this program. It has been very well received and two additional sessions were held during 2011 to cope with the demand.

Registrar Transition To Consultant Program

As many of us will be aware, very little is taught about business in medical education. The Foundation has therefore taken the initiative to establish a three-session program for final-year registrars.

This program has been established to provide fourth-year graduates with:

- 1. An overview of career opportunities in dermatology.
- 2. Practical advice from senior consultants on how private practice operates.
- 3. Advice from two senior practice managers on what it is really like to administer private practices.
- 4. Work-life balance.
- 5. Managing personal finances and financing a practice.

The program was well received by the 2010 final-year registrars and will be repeated on an annual basis. Materials from the course have also been sent to the Skin & Cancer Foundations

in Sydney and Brisbane and to the College for information.

RESEARCH

Trials

A further major ramp up of trials is proposed for 2011/2012. Early in the year, the Foundation became the first Australian centre to sign an agreement with Probity Medical Research – an international clinical trials consortium. The first trials have taken place during the year. A separate report on trials activity is to be found later in the Annual Report.

Psoriasis Registry

A significant re-write of software has been undertaken followed by an expansion of members. Ethics approval has been granted

at Royal Melbourne Hospital and Royal North Shore Hospital. We have also recently expanded into New Zealand. The Australasian Psoriasis Registry maintains an association with PsoNet – a multinational collaborative of psoriasis registries.

ODREC

Congratulations to Associate Professor Rosemary Nixon who has been appointed as an Associate Professor at Monash University. 2011 has seen continued development of the Allergen Bank. The team has been instrumental in the introduction of the Skin Checks program for workplace skin checks. A/Professor Nixon provides an ODREC report later.

Congratulations to Doctors Lee Mei Yap and Cara McDonald on the arrival of their offspring.

MESSAGE FROM EXECUTIVE DIRECTOR



2010/2011 has seen the Foundation work successfully to achieve major goals it set and broaden awareness of the Foundation's role and services.

My thanks to an energetic and enthusiastic Board for its foresight and engagement and to a committed management tean who have been so supportive in implementation.

HIGHLIGHTS

Expanded commitment to quality of service through the introduction of the Credentialing and Quality Committee (chaired by Associate Professon Chris Baker) and commencement of an ISO accreditation process

A focus on "Skin Health" and the substantial contribution of the dermatology community and the Foundation to skin health in the community.

This focus has been reflected in activities as well as brochures and online.

Reaching out to the extended community through activities such as SkinOpera, the White Night Ball and Healthy Skin Awards, a quality newsletter reaching Australia, New Zealand and International dermatologists, supporters and community groups such as the Victorian Country Women's Association

The Foundation has also taken a leadership role in the task of expanding online consultations through participation in the Australasian College of Dermatology Telehealth Task Group. I have been pleased to be a member of this task force and to be presently coordinating an inter-college task group comprising dermatology, ophthalmology and rural and remote medicine to submit a proposal to the Federal government for acceptance of Medicare benefits for store-and-forward only benefits for Telehealth. The current Medicare benefits require video conferencing.

Commencing the journey to become a "paperless office" with medical records, pathology reporting, online prescribing and other services.

Being inspired from a visit to Charité in Berlin while on leave in September 2010. It was amazing to see multiple floors providing a fully integrated inpatient and ambulatory dermatology service.

My sincere thanks to the other members of the Executive, Assoc. Prof. Foley (Research Director) and Assoc. Prof. Baker (Medical Director). Thanks also to a wonderful management team comprising of Jane English, Clinical Operations Manager, Schwards, Patient and Customer Services Manager Sue Davey, Finance Manager, Marc Brauer, Communications Coordinator, Simon Cumming, Data Manager and Karen Morris, Finance Office Their ideas, flexibility and willingness to "get in an make things happen" is a treat.

service, education and research. My thanks also to the clinical staff team at the Foundation led by Clinical Operations Manager Jane English and Customer Services Manager Sue Edwards.



RESEARCH



Message from Research Director Associate Professor Peter Foley.

The research and trial department activity continues to expand. The increasing number

of clinical trials has seen the introduction of two new nurses to the team - Anne Williams and Sheri Cloutier, and will soon include the recruitment of a data entry and administrative support person.

 Research into novel oral and injectible agents for psoriasis and psoriatic arthritis continues to be a particular area of focus and trials using innovative biological therapies for atopic dermatitis, cutaneous lupus and chronic idiopathic urticaria form part of the ongoing research in the department. A new potential topical agent for atopic dermatitis has been trialed and the team has been involved with a photo-validation study for classifying severity of glabella frown lines.

- The research activity has also expanded out into healthy volunteer trials with a current study recruiting healthy participants to donate blood for the purpose of optimisation of a diagnostic test. More studies will follow in this area and form part of the work in the department.
- With a larger number of studies on board the department has seen an increased demand for patients. Clinical Trials Connect (CTC), which was established by S&CF trial nurses Mary Pym and Christine Veljanoski, has assisted with a more efficient patient recruitment process. CTC's web-based recruitment technology and online participant screening capacity has been able to reduce the pre-screening workload on busy site staff. CTC has also played a role in facilitating patient recruitment targets into trials in a more cost efficient manner. The Consumer Health Forum of Australia (CHF) has produced a Consumer Guide to Clinical Trials fact sheet which was developed in partnership with the Department of Innovation, Industry,



- Upcoming trials at the Foundation include more studies for treatment of psoriasis, solar keratosis, rosacea and glabella frown lines.
- S&CF's arrangement with Probity Medical Research continues. PMR assist with identification of new trials for the department and offer ongoing administrative and regulatory support to the trials team. PMR will also be assisting the department with the development of new standard operating procedures (SOPs) to ensure the department's growth continues to meet regulatory and good clinical practice (GCP) guidelines and maintains service and operational excellence.

ODREC REPORT 2011 - 2012

OCCUPATIONAL DERMATOLOGY RESEARCH & EDUCATION CENTRE

- The completion of our web-based patch test program, Patchcams, combining clinic management and database. This means that clinic data is now collected electronically. Thanks to ODREC researcher/data manager/clinic nurse Amanda Palmer for her fantastic work on this project, together with our wonderful longtime computer programmer Lesley McMillan.
- Funding for different aspects of our National Contact Dermatitis Data Collection project from both Safe Work Australia and Epiderm. This project will eventually enable all Australian patchtesters to have access to the Patchcams program, customised to their own allergens, which will allow us to collect de-identified patch test data from all over Australia for the first time, to supplement our extensive Victorian database. This funding will also allow us to employ a research fellow for part of 2012. Previous research fellows have continued their interest in contact dermatitis and include Drs Adriene Lee, Helen Saunders and Jenny Cahill.
- The continuing expansion of our Contact Allergen Bank service, where we prepare and post allergens to dermatologists in order

- to facilitate their patch testing, especially when rare or unusual allergens are required. Twenty-eight dermatologists are now registered with the service.
- The ongoing contribution of Dr Jenny Cahill, who works one day a week on occupational dermatology research and who has contributed to a number of publications. We have recently submitted a report to Safe Work Australia on our experience of occupational contact dermatitis 1993-2010.
- The establishment of websites for two major international patch test organisations, the International Contact Dermatitis Research Group at www.icdrg.org and the Asia-Pacific Environmental and Occupational Dermatology Group at www.apeods.org. Our own website www.occderm.asn.au continues to attract hits from all over the world.
- The ongoing promotion of the Australian Baseline Series, comprising 60 allergens which we believe to be the most important for patch testing in Australia.



- Drs Adriene Lee, Jenny Cahill and Associate Professor Rosemary Nixon presented talks at the major international contact dermatitis meeting, held biennially, the European Society of Contact Dermatitis Symposium, held in Strasbourg in September 2010.
- A/Professor Rosemary Nixon was an invited speaker at the American Academy of Dermatology meeting in New Orleans in February 2011, and also spoke at the American Contact Dermatitis Society meeting in New Orleans.
- Our Melbourne group of patch testers, including colleague Dr Adriene Lee who patch tests at Monash Medical Centre, organised the content for the Contact Dermatitis Symposium at the Annual Scientific Meeting of the Australasian College of Dermatologists in Perth in May 2011.
- A/Professor Rosemary Nixon was an invited speaker and member of the Scientific Committee, of the Occupational and Environmental Exposure of the Skin to Chemicals Symposium, held in Toronto in June 2011
- The hosting of a number of visitors to the Occupational Dermatology Clinic, including Drs Nishan Amerasinghe from Sri

- Lanka, a steady stream of South Australian registrars, Dr Caroline Heughan, a recent dermatology graduate from Toronto, hospital medical officer Dr Chris Fessa from Sydney and medical student Ms Rowena Meani from Deakin University.
- Co-ordination of Contact Dermatitis

- Ongoing international collaborations with Professor Linn Holness (Toronto), Professor Thomas Diepgen (Heidelberg), Professor Pavikki Sustival (Finland) and Dr Danny Slodownik (Israel).
